

#### Trend I

Continuous conflicts——International order will enter a relatively long period of collapse and reconstitution. A huge vacuum may occur to public governance at global level, conflict and disorder of a certain extent will become a kind of constant state.

#### **Trend II**

## **Characteristics of the Global Changes**



**International economy and international order enter the period for extensive adjustment.** Conspicuous progress has been made in economic globalization and world multi-polarization. However, uneven resource distribution and profit distribution are obviously unfair, relatively uneven, and such trend tends to be expanded. The international political and economic pattern formed after the World War II is changing, the governance intention and ability from non-western power are conspicuously increased.



The increasingly severe global issues call for effective global governance system. The internationally traditional and non-traditional security issues are intertwined, the world' s economic growth is weak, social extreme ideological trend rises, the great change in the Middle East, the Ebola epidemic in Africa, the European refugee tide, and even the violent terrorism which took place in Paris, France and etc., all hasten the birth of the new global governance system.



**International consensus speeds up the step of the construction of the global governance system.** The international society reaches a consensus in the issues such as promoting economic transformation and development, impelling UN 2030 development agenda and the climate change conference in Paris, cracking down on terrorism and etc. and converts them into action.



**China plays an important role in the international society.** As the second largest economy in the world and the largest developing country, China should actively integrate into the process of globalization, and make proper contributions in the participation in completing the new order of international politics and economy.


## One Belt and One Road——The Economic Corridor with the Largest Span in the World


